HEALTH AGENT UPDATE

- Finalizing food inspections.
- 2 Tobacco Violations at Sunderland Gulf and Sunderland Market regarding incorrect sized cigar pricing. \$100 Violation tickets issued to both businesses 11.30.2020. Owner(s) must appeal the ticket or pay violations. 2021 Tobacco Permits will be held until matter resolved with appeal date or payment.
- Subway walk-in cooler issue noted upon inspection. Health Agent will be revisiting tomorrow.
- Self-serve coffee service is allowed. All items need to be individually wrapped, and lids to be maintained at the counter. Sunderland Corner Store was advised.

PUBLIC HEALTH NURSE UPDATE

- Ms. Rock reported free COVID testing December 15 & 16 in Greenfield for Franklin County residents information will be on website.
- Schools will be fully remote until January 4, 2021 per Superintendent's decision. Previous metrics and teacher union concerns determined decision by administration.
- 11/29/20-12/12/20: 8 new cases, 5 are UMASS students.
- Ms. Rock is now MAVEN certified.
- Ms. Rock announced she applied for and received a \$5,610 Cares fund grant for expenses incurred October-December 2020.
