### MINUTES:

### HOUSING HEALTH AGENT UPDATE

- Dumpster complaint regarding 279 Amherst Road-The Social. No evidence of complaint noted on more than one visit.
- 95 Plumtree Road complaint regarding mice and mold. Inspection was conducted yesterday; report will be generated noting observations and corrections required.

### HEALTH AGENT UPDATE

- 62 Howard Hepburn Drive – discussion regarding engineering plan. Mr. Levine is no longer involved with the project. Mr. Zimnowski will pursue another engineer. Current plan cannot be approved in its current form. A Local Upgrade Approval was requested on draft plan. Suggested Board approve that action, if needed with a new plan submission. Mr. Bennett move to approve a Local Upgrade Approval from water separation table, i.e., for a pressure system, if needed, Mr. Kushi second, vote 3-0.
- Health agent completed CEO Swimming Pool Inspection Course for recertification.
- Several title 5 inspections completed.
- Conducted three (3) food inspections at Sunderland Market due to the result of a complaint.
- The O's kitchen plan has not been received yet but was submitted to building commissioner; agent will follow-up.

### PUBLIC HEALTH NURSE UPDATE:

- PH Nurse is available to provide test kits and PCR home testing as requested. No inquiries have been received at this time. Inquiries are forwarded to PHN directly.
- Request PH Nurse review the town's MAVEN account access for second account to pause access at this time.

- State Animal Inspector Appointment recommendation for approval for Emmie Martin who is also the town's Animal Control officer. Mr. Bennett motion to accept appointment recommendation to the state for Ms. Martin, Mr. Kushi second, vote 3-0.

- Board members thanked Ms. Rock for her service as she is not seeking re-election.
