# HOUSING HEALTH AGENT UPDATE

Mr. Ball accompanied Ms. McNeely on inspection with tenant at 93 Plumtree Rd. Recent incident
was reported to Police and report was taken but accident report was not filed due to it taking place
on personal property. This is not a Board of Health housing matter. Multiple complaints have
been received from the tenant at this property, none of which are Board of Health Housing
matters.

## **HEALTH AGENT UPDATE**

- Mr. Ball reported septic services increased significantly in the recent month.
- Commercial kitchen inspections are being done as more businesses open for the spring/summer months.
- 2 Local upgrade approvals requested for 153 Hadley Road.
  - To allow for sieve test results rather than a perc test. Sieve test results can be more conservative. Perc test on this property would be very expensive due to high water table. System will be a mound system due to the water issues.
  - o Reduction of ground separation from 5ft to 4ft as second local approval requested. Neither of these requests will have an impact on human health, environment, or safety. Goal of the Board of Health is to maintain maximum feasible compliance. Mr. Bennett moved to grant local upgrade options as presented, Mr. Kushi second, Vote 3-0.

## PUBLIC HEALTH NURSE UPDATE

- Ms. Rock reported that there are no cases on MAVEN as of today.
- Memorial Day Ceremonies must meet state guidelines. The guidelines will be changing next week, however the day after the planned event. Everyone will be asked to observe social distancing.
