Selectmen's Meeting Monday, February 11, 2019 Town Office Building

Meeting called to order at 6:33PM

SCEMS BUDGET PRESENTATION

Zach Smith, Director of SCEMS presented their FY20 budget. Budget includes step and COLA increases for personnel; Deerfield's comp study implemented a 10-yr, 10 step compensation with 2% COLA. Other increases included county retirement at 10% and health insurance 12%. Operating Expenses includes a decrease in rent due to the new facility. Rent expenses will be used for future building maintenance and a special fund established. 10% indirect costs for Deerfield personnel is being reviewed and may be adjusted. Collection of service fees has been good with ComStar. Operational reserve line is \$100,000. Sunderland's assessment is 31.48%. SCEMS is able to provide 24/7 paramedics, outreach and working with the community regarding services. Franklin County Radio assesses member towns and SCEMS portion is \$67,000. Other options are being explored, including option to join state service.

SCEMS CAPITAL

Under a separate budget for capital, two items were submitted. One for an ambulance replacement and another for a second vehicle with an estimated cost of \$40,000. BoO has not voted yet and no assessment to member towns has been determined. \$50-55,000 retained annually and earmarked for ambulance replacement. Mr. Bergeron encouraged the BoO to formulate an approach for use of retained earnings. It was noted an increase in runs from 10% average to 13% due to aging population which is trending nationally. Mr. Smith noted people are quicker to call for services because it is available. Service does some assists to Conway who operates a volunteer service. Collection rates are 80% vs. 20% uncollected fees. Most fees are paid 93% from insurance and 7% covered by co-pays. It was noted that SCEMS is a service, not a profit center. Mr. Crowe asked, what costs are related to opiate cases. Mr. Smith reported they are working with other organizations and Narcan is free; calls/costs have decreased.

<u>FIRE DEPARTMENT</u> – <u>Physicals</u>. Physicals are not needed per OSHA written notification to the Fire Chief – only required for new officers. \$6,000 funds appropriated at STM 1.28.19 will be returned to the town.
