## FIRE DEPARTMENT BUDGET PRESENTATION

Fire Chief appeared presented the department's FY20 budget. Budgets includes additional funds for part-time call firefights noting increased calls. Wage increase for administrative assistance to accommodate public works and OSHA regulations. Expenses have increased, including additional \$6,000 for OSHA mandated physicals for 10 members. Additional members qualify but will be phased in. The physicals are a one-time expense, future requirements will require personal physician documentation to be able to perform duties. E. Crowe asked for clarification of increased calls, i.e., due to complexes? New populations in complexes every 6-12 months, increased auto accidents on Rt 116 and Bull Hill and a major fire this year. Capital Requests include exhaust release for bay issue which has drawn employee complaints. Building was not required to have this equipment when built. New truck delivery is expected in August. Outdoor burning permits available online.
