Call to Order

• Meeting called to order at 6:39 PM.

• Mr. Fydenkevez acknowledged the passing of Philip Gilmore Sr., a Deerfield resident who was a former EMT and EMT instructor. The board observed a moment of silence in memory of Mr. Gilmore.

Appointments

• Appointment with Library Director to be rescheduled.

The board met with Dorey Huard of the Bartholomew Group to discuss Other Post-Employment Benefits (OPEB) services. Ms. Huard gave a brief overview of the services provided by Bartholomew Group with regard to investment of funds for future postemployment benefits such as health and life insurance. The Bartholomew currently provides services to over 200 communities, of which 100 have OPEB Trusts. Ms. Huard advised that GASB accounting principles set regulations on how financial benefits must be reported and how they are accounted for. These regulations came into effect in 2005. Reporting on how funding is to be addressed was scheduled to begin in 2009. These regulations look at costs to fund future retirement benefits and how much that liability will cost in future years. Money put into the trust is invested in the stock market to earn funds so that these costs are not just born by taxpayers. Legislation has been proposed under the Governor's 2016 Municipal Modernization Bill to establish an irrevocable trust. Currently the law allows you to put money into an account and invest funds. Most communities typically invest funds conservatively. Typically 75-90% of funds are invested in government bonds and CD's. However, if a higher rate of return is desired, a more aggressive approach is necessary to see a rate of return between 6-7% annually. The Bartholomew group provides services to assist the Town and Treasurer with implementing recommendations set forth for OPEB including risk level recommendations, investment policy development, and oversight.

• Mr. Pierce stated that a meeting was held last Friday to discuss cable contract. Mr. Pierce advised that that a meeting was held last Friday to discuss final Comcast Cable Contract. The final contract for approval should be received shortly.

• Mr. Fydenkevez advised that South County EMS Board of Oversight met last Thursday accepted the recommendation of the Building Committee with regard to the RFP for housing of the SCEMS. Two proposals were received, one for the Whately Municipal Building and one for the Old South Deerfield Fire Station. Whately building scored highest. Upon recommendation of the Deerfield Town Administrator all bids were rejected and to recommend that the Whately Facility and recommend that the Deerfield Selectmen enter into negotiations with Whately.

Town Administrator Updates

• Meeting with Energia and Guardian to finish up building envelope improvements and the Public Safety Complex, Town Office Building and Library. The Order of Taking for the School Street parcel has been recorded. Attended the Community Preservation Committee Public Hearing to discuss possibility of applying for a PARC Grant for improvements along the river. Concerns were expressed at the meeting regarding parking, maintenance of new and existing fields and river impact. The overall general consensus following the meeting is to address concerns and apply for grant funding next year. Ms. Patch also advised that she is looking at a possible LED Streetlights project for grant funding under DOER funding or Complete Streets.
