Smartphone App:

If the Zoom Cloud Meetings app is not already installed on your device:

- i. Click the Download button

- ii. Install the app
 - iii. Return to your browser
 - iv. Click Join Meeting
 - v. Allow the link to open in the Zoom app
- 2) If the app is already installed on your device allow the link to open in the Zoom app or click Join Meeting You will be asked to enter your name before joining, or the name of your phone will be used.

Computer:

- 1) Go to <https://us02web.zoom.us/j/81721278936>
- 2) You will be asked to download and run an application that will connect you to the meeting
- 3) If you choose not to run the application, there is a link to join from your browser
- 4) You will be asked to enter your name before joining

Troubleshooting Tips:
