## HOUSING HEALTH AGENT UPDATE

- 87 N Silver Lane: 6.25.18 re-inspection scheduled. Occupant was given a clear list of items to work on previously. Property owner did sign and accept certified letter sent previously.
- 28 River Road-Apt 160: Flood occurred and after inspection, an order to correct was issued to the apartment complex. Tenant was told 6.11.18 to vacate apartment for two (2) weeks to abate damage, carpet and wall to be replaced.
- 253 Amherst Road-Apt A12: Upon re-inspection, was informed that the apartment was rented to different tenants.
- POUND THE PAVEMENT event held 6.2.18. Agent performed food inspection for one permitted vendor. At event, another vendor was present and was giving away free ice cream. Ms. McNeely worked with them to get up to code. A third vendor was observed giving samples of bark thins chocolate. Ms. McNeely reviewed the code requirements with them as well.
