- 87 N. Silver Lane ó Update: appointments arrived at 6:25PM. The following neighbors were present: Sandy Littell, Peter Littell, Bryan Simmons and Jayne Witzenbocker. It was noted when matter was brought to Housing Court in Greenfield, Honorable Judge Robert Fields will no longer allow municipal officials to bring code enforcement cases without being represented by an attorney. Neighbors voiced concerns over resident going through neighbor¢s recyclables and taking items storing on his property. A dumpster has been on the property since August and nothing has been removed. A case conference is scheduled for November 30, 2018. Actions to be done by Housing Health Agent: 1) contact electric company, water department and alert police of current situation; 2) Town Counsel to be updated and request letter of clarification to Housing Court by Honorable Robert Fields; 3) Letter to be sent to Service Net case worker to be advised of safety and health concern issues.
