6:03PM— Meeting with Building and Electrical Inspectors, Board of Selectmen member, Town Administrator and Planning Board regarding housing concerns related to old houses being used as rentals and housing several tenants. Questions regarding room house vs. boarding house definitions and discrepancy with Town By-law vs. State Code were discussed. Further concerns of the Board of Health relate to access gained for a property because of a housing complaint and who the follow-up should be with for repairs, etc. and who the owner/responsible party identity is. There are also issues related to absentee landlords for properties. Discussion issues also included identifying unrelated persons in homes and how to enforce laws, related fines, etc. Planning Board members reported they would be overhauling the Town's bylaws and will review the state regulations. Possibilities to address some of these issues could be rental registration or permitting for properties. Landlord representatives discussed to look at enforcement of codes, contact, personal-written, etc. Electrical and Building bylaws need to be updated. Board of Selectmen to be notified about increasing enforcement powers.
