

2024 FRONTIER REC SOFTBALL LEAGUE SUNDERLAND RECREATION Grade 2 – 9 <u>REGISTRATION SESSIONS</u>

Players registered with the Sunderland Recreation Softball Program will be placed onto the roster of a team to play in the Frontier Youth Rec Softball League for the 2024 season. The Frontier Youth Softball League is a modified-fast pitch softball program open to girls in grades 2, 3, 4, 5 & 6. We also field a Middle School team for Grades 7-9 which typically begins play

in mid-May. All of our teams participate in the Quabbin Valley Softball League.

As in past years we will mix the girls together from the five towns onto teams at both the grades 2-3/4 and grades 4-6 levels. Some 4th graders are "swing" players that will play at the level of their ability depending on team numbers. Players will be evaluated at a <u>Skills</u> <u>Assessment</u>, to be held in the Frontier Regional High School gym on <u>Saturday, March 23rd</u> between 9 am and 1 pm. (Specific times per grade TBD)

A <u>Pitcher's Clinic</u> will be held for girls in grades 4-6 who want to pitch this year. The date and time will be announced shortly.

A <u>Spring Training Skills Clinic</u> will be held for girls in grades 2-6 registered through Sunderland Recreation on <u>Thursday, March 21st from 5:30-7 p.m. in the</u> <u>Sunderland Gym</u>, put on by Sunderland Recreation.

<u>The season runs from April 22nd thru June 15th</u>. There is a end-of-year Jamboree for the Grade 2-4 teams on Saturday, June 15th in Belchertown. Playoffs for Grades 5&6 and the Middle School team take place from June 18th through 23rd. Most teams practice twice a week until the season starts. Once the season starts, there may be one practice per week with games on weekday evenings, Saturdays and/or Sunday afternoons. Practices will start the week of April 1st and games begin the week of April 22nd.

Registration for the Middle School team is open now thru April 15th.

The cost of the program is \$75 registration fee for grades 2-4 and \$85 for grades 5-9 (players will be responsible for purchase of their own pants or shorts). <u>Make checks payable to</u>: Town of Sunderland.

<u>Registration Sessions</u>: In-person Registration will take place on <u>Tues., March 5th & Thurs.,</u> <u>March 7th from 5:15 – 7:00 p.m. and Sat., March 9th from 9 a.m. – 12 noon at the</u> <u>Sunderland Elem School</u>. Registration and Consent Release forms can also be obtained on the Town Website under the Recreation Dept.
