## **OLD BUSINESS**

- SELECTBOARD UPDATES:
  - o Mr. Pierce has an upcoming Frontier Capital Committee meeting
  - Ms. Drake-Tremblay has no new reports.
  - Mr. Fydenkevez noted a SoCEMS meeting tomorrow. The service marks 10-years. Also noted the South County Senior Center (SCSC) April Newsletter notes a presentation on April 22<sup>nd</sup> for Sunderland Senior Housing information session from 10:30-noon at the 29 Sugarloaf Street. Meeting will be posted on town website and Community Channel.
- TOWN ADMINISTRATOR UPDATES:
  - o ARPA phones at Sunderland Elementary \$24,750. Mr. Fydenkevez is still looking a detailed narrative about the phone system regarding replacement information, equipment types, etc. School reports current phones have reached their "end of life." Mr. Pierce motion to approve use of ARPA funds for Elementary School phone replacement, Ms. Drake-Tremblay, vote 3-0.
  - o Mr. Fydenkevez requested research with the town clerk's laser fiche regarding the glycol material in fire suppression system and asbestos removal.
  - o Board of Assessor's voted the use of \$24,000 in overlay surplus at their meeting tonight, which closes the gap some in the budget which is larger than originally anticipated because abatements are higher. Mr. Kravitz noted that budgets are tight and everything is more expensive.
  - o Treasurer-Collector follow-up with 457 Plan. If the town limits changes to contributions to once per year, then the plan should be manageable for her department.
  - O Board Ramp sidewalk work began and is expected to be completed by the end of the week.
  - o Baltazar update regarding town's issues with North Main Street upgrade. Mr. Kravitz the town did receive some compensation for damages. Town has an approved plan by designers; still need to talk to property owners and obtain right-of-way entry.
- Next Selectboard meeting is scheduled for April 11, 2022, 6:30PM.
