The Board expressed condolences on the recent loss of our Highway employee, Chris Sibley.

Mr. Bergeron thanked residents for coming the North Main Street reconstruction project public hearing. The public comment period is open 10/7/19.

SELECTBOARD UPDATES

- Mr. Bergeron said a Capital Planning Meeting will be held next Tuesday.
- Mr. Fydenkevez addressed the questions received regarding the markers on S. Main Street. The "sharrows" indicate to motorists and bicyclists to share the road. Traffic Light cycle changes are being explored on Rt 116 and Rt 47 by MassDOT.
- Mr. Pierce said the first Personnel Committee meeting addressed goals for the year.
- Mr. Bergeron note the Board will sign a bond for \$122,500 for 120 N. Main Street at 1.95% for one year which requires an annual authorization.

Mr. Fydenkevez would like to focus on hiring a Town Administrator rather than an Interim, Mr. Pierce agrees. Mr. Bergeron recommends a screening committee to review applicants, suggest the Personnel Committee to screen applicants and make candidate recommendations to the Board by the middle to end of November.
