6:35PMPublic Hearing for ALTERATION OF PREMISE LICENSE FOR BRIDGESIDE GRILLE. Mr. Bergeron read posted notice and opened the hearing. Atty. Brad Shimmel presented the request on behalf of owner John Reilly. The Board read correspondence from abutters in support of the application from Michael Skibiski and Barbara Skibiski.
