APPOINTMENT OF HIGHWAY LABORER: Highway Superintendent recommended appointing Arnold Rose as a highway laborer. Mr. Fydenkevez motion to appoint, Mr. Bergeron second, vote 3-0.

COVID-19 UPDATE: Ms. Smith stated that the numbers were still looking good this week. 7 active cases, with another one added that day. She picked up and distributed PPE from MEMA to departments over the weekend. The CDC has issued guidance for people who have been vaccinated. He noted that the county is trying to secure vaccines for teachers and school staff.

The Town Administrator noted that the town was awarded a Local Rapid Recovery Planning technical assistance grant to plan for pandemic recovery. The contract with the Riverside Park restroom designers is being finalized. The Frontier School Committee Budget Hearing is scheduled for March 9.
